Standard terms and conditions of the www.vharmonika.com website

GENERAL

The website www.vharmonika.com is a virtual teacher, managed by the World Association of accordion lovers – the provider of the website or the services.

These standard terms and conditions refer to all users and to all ways of using the website www.vharmonika.com.

Terms and conditions are regularly supplemented and their full text is available in their latest version on the website at every moment.

If you do not agree with the terms and conditions, fully or partly, we summon you to stop visiting our website.

Users are allowed to use the online workbook www.vharmonika.com individually and for their personal purpose only. Due to the technical limitations, the usage of online service is enabled only for personal computers with internet connection on Google Chrome or Microsoft Edge.

In the process of registration, visitors receive a username and a password that enable them access to their accounts ("My profile") every time they visit the website. In that way they get the right to access the individual chosen files, while their username and password are linked to the entered data.

Standard terms and conditions determine the functioning of the online service and the rights of users as well as the business relationship between the website's owner (who is also the provider) and the customer.

COPYRIGHTS – THE PROTECTION OF INTELLECTUAL PROPERTY

The contents on the website are the property of the provider or/and partners, contract co-workers or are marked with the source or the author. All original works of authors are protected from the very beginning of their existence, so there is no need to be specially labelled. The original works include all written, imagery, sound and other material.

The provider holds the right to act against those who may infringe the rights of intellectual property according to the current legislation: copying, distribution, transmitting, showing, reproducing, publishing, creating different versions, selling or changing any information and contents from the website www.vharmonika.com is forbidden without the written agreement of the website's manager.

PRICES AND CONDITIONS OF THE PURCHASE

The currency of every price is euro and they include VAT regulated by the law. Persons liable for tax have to give their tax ID number at the time of registration.

The potential costs of delivery are not included in the price.

The prices are valid from the moment you send the order and the price validity is not determined in advance.

The website www.vharmonika.com issues a bill for the purchased access to the individual files to the buyer or user and it delivers it either by e-mail or physically on the address given at the time of registration.

The buyer is obliged to check the data on the bill and inform the provider about the potential mistakes within 8 days since the delivery.

Any objections to the irregularities of the issued bills notified later will not be taken into account.

Online and special prices are valid exclusively for the purchases on the website www.vharmonika.com. The potential discounts do not add together.

The provider is obliged to ensure the currency of data and their correctness. However, the price of the access can change.

In case the price of the access to a particular product changes while processing the order, the provider informs the user about it.

The provider is obliged to try to ensure the buyer the lowest possible price or offer the proper solution that would please both, the user and the provider.

The contract between the provider and the user is awarded when the seller confirms the order for the access to a particular content and when the user receives the email, confirming the order or purchase.

From that moment on, all prices and other conditions are valid for both, the provider and the user.

The potential discounts do not add together and every potential paid-up assets using pro forma invoice do not pay off.

The prices on the website www.vharmonika.com can change without prior notification!

ORDER AND PURCHASE

The process of ordering takes place on the internet 24 hours per day on every day of the year.

The users choose and order or buy the access to a particular content (song) that is available in the online store and are sorted by different categories.

Purchased access to a particular file lasts indefinitely or until the users stop using the website – meaning logging out of the website or a long-term inactivity; to be exact, when the user does not log in "My profile" for more than a year.

Ordering the access: After the order has been sent, the user receives an email, confirming the order together with the attachment in the PDF format. To read the order in the PDF format the user has to have the Acrobat Reader programme.

Confirmation of the order: The provider checks the order and either confirms it or rejects it due to a good reason. The provider can contact the user, using the given data to check the data and to ensure the punctuality of delivery.

In the email, the provider informs the users about the purchase's confirmation, instructs them about the policy concerning the withdrawal from the contract or notifies them that they can always turn to the provider in case of any confusion.

PURCHASING THE ACCESS TO THE CONTENTS

Purchasing the access to the individual contents (songs) can be carried out only by the registered user. After clicking the button "BUY", the website directs the user to the page with the selection of payment methods. The payment being carried out, a melody with

the studying programme is loaded to the user's personal base in the section "My songs" and it is ready to be used.

COMPLAINTS

The payment cannot be returned for the purchased access to a particular content (song). It is also not possible to claim back any other costs or replace an already bought song. In case the programme does not work, the manager is obliged to replace the file with an identical, a working one without any additional costs.

PAYMENT METHODS

You can use the following payment methods to shop on the website:

- Money transfer to the current account of the website's manager (World Association of accordion lovers) after receiving pro forma invoice,
- Moneta (for the users which have a Slovenian mobile operator),
- PayPal

Sales contract (confirmed order) is saved in the electronic form on the manager's server. In this way, it is available to the user on their profile 24 hours per day ("My profile" → "My purchases").

PRIVACY AND PERSONAL DATA PROTECTION

The website www.vharmonika.com is allowed to collect certain information about your visit, such as the provider's name and IP-address (Internet Protocol) through which you accessed on the internet, the location, date and time of your access, the pages you visited as well as the internet address from which you accessed to our website.

The website www.vharmonika.com uses a function for tracking the location from which a user logs in. In case of any potential abuses, the infringer will be temporarily unable to access the website and will be contacted over the telephone or email.

With the registration for our website www.vharmonika.com you allow the provider to establish, collect, manage, use, process and save personal data of users in the collections of personal data with the purpose to assert the rights, stated in the contract and to market directly, for the unlimited period of time.

You can either demand to fix your data or to stop using the data within 15 days with the purpose of direct marketing over the email (info@vharmonika.com). The provider guarantees the protection of personal data according to the Data Protection Act.

The provider will use or disclose the given data of registered users only for the purposes for which the data were collected and with the agreement of the user or according to the official demand by the organs of the Republic of Slovenia and regulation GDPR.

With the acceptance of these terms and conditions and with using the service the users agree that the provider cannot ensure the protection or the privacy of the information which are transformed over the internet or email and that the provider will not be considered responsible for the use of these information by a third party.

With the acceptance of terms and conditions, the users agree that the provider is not responsible for the actions of the third parties in connection to information sent by themselves.
